Применение биотехнологических спутников в международном терроризме, постоянных пытках, диверсии, селективных и массовых убийствах может не являться зафиксированным нарушением в уголовном законодательстве США, хотя многомиллиардная американская корпорация нанимала иностранцев в течение системно-образующего совершения таких преступлений со известными результатами в России и в США: производство политиков, массовые убийства собственных граждан, "замедление вашего развития".

Серьезный материал готов к публикации, но я - автор, подвергаюсь полицей, полувоенными группами и финансовыми организациями (якобы находящимися под влиянием одного Датского и нескольких Шведских банков) постоянным атакам на головной мозг и внутренние органы. Есть основания ожидать еще более суровых пыток и несанкционированных законом «наказаний» в ответ, например, на мою «дерзость» уличить предателей в рядах федеральных органов безопасности России.

Эстонская налоговая служба согласилась с тем чтобы мой рублевый счет (Sberbank Rossii) был использован для комерческих переводов.

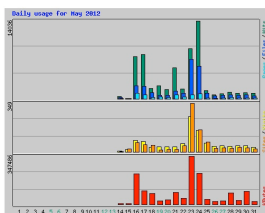

Greetings:

Around September 18th, 2011 your company should have received by email a proposal for the distribution and sale of four books published by Artime Consulting (*with a digitally-signed copy*). Since then, satellite attacks to the brain have increased and become an instrument for Estonia-based extreme-right groups to coax and sabotage (*photos available*). Civilians and uniformed Estonian policemen and military openly partake in nuclear “medicine” satellite brain scanning and torture operations to protect oil industry private interests and large Estonian banks’ financial (*some concurring*) paramilitary crimes (*photos available*). Several chapters of one of the books have been enhanced by current official documentary evidence of violent and illegal operations to quench political opposition in Russia and other states.

Artime Consulting’s sites now offer the possibility of instant credit card payments and of establishing a network of stores (*digitally-signed contract prototype attached*). A unique set of user name and two pass words are at your disposal to test online registration and bookkeeping capabilities. Complete business functionality is ensured by contracts with several printing houses, logistics companies (*UPS, DB Schenker, DHL, Eesti Post and TNT*) and banks (*Nordea and Swedbank business accounts, Sberbank Rossii: personal account can be used while Artime Consulting’s business account is set up*).

Available photographs prove the complicity of the Estonian military in the assassination of Colonel Gaddafi (*as you know, it happened on October 20th, 2011*), which was carefully prepared by the French police, using the Cubana de Aviacion aircraft bombing by Cuban CIA terrorists near Barbados in 1976 (*proofs available*). Before, during and after the NATO invasion of Libya, French military agents came to Tallinn especially to make the connection between me, Muammar Gaddafi and members of his family, who were also targeted by the French police to secure the stability of political agreements and joint investments in Cuba (*I had met a member of the Latvia mission in NATO’s Brussels HQ and high officers of the Central Military Prosecutor’s Office in Moscow before the start of the invasion of Libya*). A few days ago I received a letter from USA Senator John McCain regarding the ongoing civil strife in Syria, after the Syrian embassy in Madrid had replied to my email on the subject of French involvement in a particular high-profile crime in Syria. These and other facts indicate that the information contained in the books that Artime Consulting proposes will quickly find a market on the territories of the former USSR, Europe, the Middle East, Latin America, Asia and the USA.

My intention is not to promote myself politically but to alert the general public about serious high-technology (*biotechnology*) violations of human and civil rights by military, police and private “security” companies. Personal meetings will be feasible when I start traveling next month.

Due to real-time communication hindrance I cannot construe the absence of a reply as indifference. Thank you for your consideration,

*With only a few exceptions, all messages included in these books were outbound. The reply email from the embassy of Syria in Madrid concerning the assassination in Damascus of the director of a military hospital (committed with the participation of Cubans and the implementation of military satellite biotechnology) does not stand conspicuously from the rest of denounced events. Ill-wishers might interpret the email exchange as involvement in massacres or civil war preparation operations (Douma bombardment, Zamalka funeral procession car bomb, etc.) but they would make up the minority: such fabrications will not withstand independent criminal or journalistic investigations, not even common sense.*

*Seldom I received responses from embassies or security/military agencies. All replies sent by email/postal service from the International Criminal Court, the Federal Security Service of the Russian Federation, the European Court of Human Rights and the Russian Military Prosecutor's Office were negative, although unofficially, I counted with the support of some of their functionaries. Emails could be intercepted or detoured; on paper, they might be legally binding.*

*(While working in the reception of Tallinn's Barons Hotel wired bandits interfere my laptop as I type and continuously torture by making comments and "noises" in person or by using the ambience music; more threats of deportation if I create problems).*

*The interaction between the USA Federal Government (CIA) and my family goes back to Manuel Artime but I am not a client of the agency. Nuclear satellite technology use by military, multinational corporations and banks/financial institutions on civilians to torture, scan the brain (and read thoughts), sabotage and disrupt justice is an act of international terrorism. In France (and Brussels), Russia, Latvia and Estonia numerous individuals affiliated with extreme-right military groups and local police employ such technology also for thefts and monopolization. Presidents are thus fabricated, sometimes 25 years in advance, to play the role of "national security" guarantors. The collar-bomb murder of farmer Elvira Cortes in "La Palestina" (Colombia, year 2000) by financial criminals is an irrefutable proof of French police-roofed export of international military terrorism.*

*Putting pressure on society for legal definitions of pervasive high-technology crimes, the recognition of the disparity of means to fight organised white collar crooks and the start of criminal proceedings against assassins, torturers and mass murderers (men and women) is the main purpose of this publication.*
